#### Overview:

Cardinal Community Academy Charter School is a public charter school serving students in grades kindergarten through eighth grade. The school opened in 2000 with seventy-five students, and has grown in student numbers every year.

- Attend all meetings of the Cardinal Community Academy Board on the 4<sup>th</sup> Wednesday of every month at 5:30PM, as well as emergency or work session meetings, when needed.
- Attend and support, when possible, school functions, fundraisers and events.

### **Process Overview:**

Individuals interested in serving on the Board of Directors will be asked to complete the <a href="CCA Board">CCA Board</a>
<a href="Application">Application</a>, that can also be found online on the Board of Directors page on the website, by 3:30pm on September 6th. At the discretion of the election official, there may be a virtual or in-person meet and greet held to introduce applicants to the community. Interested candidates will be added to a slate for vote by the parents of the school during the week of Parent-Teacher conferences.

All elected Board members will begin their terms starting January 1, 2023. You are asked to attend the board meetings starting in October to observe. Two of the terms, one parent and one community member, will be filling regular, three year terms. The other two, one parent and one community member, will be filling two year terms.
